1. The name of the company is **Paradis Des Enfants Entertainment Limited**.
2. The Registered Office of the Company will be situated in Seychelles.
3. The objects for which the Company is established are:-
 - (a) To manage family amusement, fun parks and entertainment facilities;
 - (b) To develop and provide year round quality family entertainment activities;
 - (c) To design and provide facilities which address the entertainment needs of not only young children but also that of teenagers and young adults in a safe and secure environment;
 - (d) To organise events which will bring the entire family together in a secure and safe environment;
 - (e) To encourage entrepreneurship in the management of the facilities owned by the company;
 - (f) To lease or rent the facilities owned by the company;
 - (g) To direct or manage the development of land, buildings and other infrastructures and any other property of the company for the creation of amusement parks and other family entertainment activities;
 - (h) To borrow or raise or secure funds or make advances or enter into guarantees for the development of company properties and to purchase, redeem or pay off such loans or securities
 - (i) To invest the funds of the company not immediately required in such a manner to maximise revenue generation as may from time to time be determined.
 - (j) To acquire by lease or otherwise, maintain, equip and operate offices for the purpose of the company
 - (k) To carry out any other activity which is incidental to the attainment of the foregoing objects
4. The liability of the members of the Company is limited.
5. The share capital of the Company consists of **100 (ONE HUNDRED)** ordinary shares with a nominal value of **ONE HUNDRED (R100)** each. The nominal capital of the Company (being its nominal capital in respect of those shares) is **TEN HOUSAND (R10,000)**.
